




- Created by Maastricht Treaty (1993)
- To give local and regional governments a say over the drafting of EU legislation (70% of EU laws are implemented at local/regional level)
- To bring Europe closer to its citizens and to encourage a culture of subsidiarity
- To provide a meeting place where regions and cities can share best practice and take part in a dialogue with the European institutions
- 344 members representing local and regional governments plus 344 alternates



### CoR welcomed Europe 2020, provided that...


- it is implemented in a flexible way, to take into account territorial differences in development levels, assets and institutional capabilities

### **Up-coming Europe 2020 review**






03/03/2010, Launch of the Europe 2020 Strategy



- CoR intends to participate at an early stage in the review of the strategy.
- CoR will contribute to the mid-term review foreseen by the Commission and the Council in 2014/2015 from a local and regional perspective taking due account of the actual division of powers between government levels.



#### **Europe 2020 Mid-term assessment**



- Follow-up: at the institutional level all the relevant stakeholders will be addressed
- 2014 Spring European Council (March 2014)
- President of the European Council
- > Rotating Presidency of the Council of the EU and Council administration;
- > European Commission both the present and the new College (appointment in the second part of 2014);
- European Parliament
- Permanent Representatives of the EU Member States
- European Economic and Social Committee


### **Towards the mid-term review of Europe 2020**

"The Europe 2020 Strategy is the most relevant policy area of the EU to overcome the financial, economic and social crisis. Preliminary results of CoR assessment of the Strategy at local level also clearly show the **key role of cities and regions in developing place-based strategies for growth and employment**. If we want the Europe 2020 Strategy to succeed, we need a new approach to **strengthen its territorial dimension** and truly ensure **multi-level partnership** in its planning and implementation"

## Energy related functions of local and regional authorities

- 1. Energy consumers and service providers
- 2. Planners, developers and regulators
- 3. Advisors, motivators, role models
- 4. Producers& suppliers
- 5. Buyers
- due to the differences in the division of powers (national-regional-local) these functions and their scale varies across EU28 (see detailed charts)

## Examples of relevant CoR Opinions (2)

#### CoR Opinion on Energy Roadmap 2050:

- "We wholeheartedly support the Commission's strategy but proper funding and support is needed if we are to unlock the potential of local and regional authorities in delivering these ambitious goals".
- "Local and regional authorities are on the front line when it comes to delivering planning, managing public contracts, managing production and controlling energy consumption. They are involved in implementing national energy plans and are also responsible for certain forms of energy production, processing, transport, storage and waste treatment infrastructure".
- ➤ The CoR also raised concerns about the lack of reference to the energy efficiency of buildings in the Roadmap. Though buildings use about 40% of all primary energy in the EU, insufficient investment was being directed into reducing building energy emissions, an area of responsibility for local and regional authorities

### CoR standpoint

- Priority should be given to integrating renewable energy into the distribution network, produced at local level,
- The CoR advocates investment in integrating locally produced renewable energy into the grid.
- In addition to the ERDF funding, public-private partnerships for sustainable local and regional investment should be encouraged through funding mechanisms such as low/zero interest loans, bank guarantees, local revolving funds and other innovative financial engineering tools.
